### **Mithril Resources Limited Rights Issue**

On 19 November 2018, Mithril Resources Limited (**Company**) announced a five for six non-renounceable pro rata rights issue at an issue price of \$0.005 (0.5 cents) per share (**Rights Issue**). Eligible shareholders registered as at 22 November 2018 will be entitled to participate in the Rights Issue in respect of the number of shares they are the registered shareholder of.

The Company has decided, pursuant to Listing Rule 7.7.1 of the ASX Listing Rules, that it is unreasonable to make the offer to shareholders who have a registered address in a country outside of Australia or New Zealand (**Excluded Shareholders**) having regard to:

- the small number of shareholders with addresses in these other countries;
- the number and value of the shares they hold; and
- the cost to the Company of complying with the legal requirements and the requirements of the regulatory authorities in each of the other countries concerned.

We regret that the Rights Issue is therefore not able to be extended to Excluded Shareholders. Excluded Shareholders will not receive a copy of the Rights Issue Prospectus.
